The first Meeting of the Regional Steering Committee

13 March 2018, Tashkent, Republic of Uzbekistan

The event was conducted under the project "Central Asia Nexus Dialogue Project "Fostering Water, Energy and Food Security Nexus Dialogue and Multi-Sector Investment in Central Asia" (the "NEXUS Project"), funded by the European Union.

Participants

The First Meeting of the Regional Steering Committee (RSC) was attended by 20 participants (45% women), including:

- Nine representatives of key project partners from national governments involved in water, energy and food security management in Republic Kazakhstan, Republic Tajikistan, Turkmenistan and Republic of Uzbekistan. Most of them are heads of departments. Two representatives of the International Fund for Saving the Aral Sea (EC IFAS in Turkmenistan and IFAS Executive Board of the Republic Kazakhstan);
- Two participants from the Delegations of the European Union to Republic of Kazakhstan and Republic of Uzbekistan;
- One international expert on river basin management and water diplomacy, Senior advisor to the European Commission;
- Eight Nexus project team members from the Central Asia Regional Environmental Centre (CAREC) and International Union for Conservation of Nature (IUCN).

Meeting's objectives

The meeting main goal was to discuss opportunities provided by intersectoral approach to planning investment projects for ensuring water, energy and food security in Central Asia, and have this approach validated by the countries of Central Asia. The meeting objective was also to establish a Regional Working Group (RWG) to support further implementation of the Nexus Project (*Annexes 1 and 2*).

Achieved results

All main goals and objectives of the meeting were achieved as follows:

- The participants validated the proposed approach to implementation of the Nexus Project in Central Asia. In particular, its close cooperation with EC IFAS, merging processes of developing Nexus-based investment projects with development of ASBP-4 Programme, consideration of pending projects from ASBP-3 (of regional interest) for inclusion into the Nexus Project's pipeline;
- The participants expressed their readiness to contribute to building the working relationship between the Nexus Project and the ASBP-4 development teams in their respective countries;
- The Nexus Project Regional Working Group (RWG) was established, the Terms of Reference and working p for 2018 has been approved (*Annex 3*).

- Participants were informed about the global Nexus Programme, which is being implementing in five regions and covers more than 55 countries, the experience and lessons learned from other regions on application of the Nexus approach in basin investment planning;
- The opportunities offered by the European Union Investment Fund for Central Asia (IFCA), which currently has EUR 122 billion available for CA states, presented and discussed, have been discussed.

Received recommendations

- To develop Web-GIS based platform of proposed investment projects in Central Asia with main rivers, land and infrastructure related to water, energy and agriculture management layers for development of ASBP-4 investment projects;
- To use the tools which are currently being developed by the EU-funded Project "WECOOP2", such as the Investor Guide and the web-based Regional Knowledge Centre with an interactive platform for communication with banks by Nexus partners and other stakeholders;
- WEF Nexus based investment projects for Central Asia can include: 1) creation of Central Asia water-energy management holding, 2) consulting company to support development of project proposals, 3) water quality of Kyzylorda river, 4) green belt of the Aral Sea;
- The capacity building program can include: development of a training module or even the course (10-15 hours) on WEF Nexus approach for strategic planning. Existing national centers for advanced training of civil servants, which exist in all CA countries, can be engaged as partners;
- Study-tour to the basin, in which Nexus approach has been successfully applied for basin planning, can be quite useful for project partners. Senegal or Columbia basin management can be considered as the best practice for studying;
- Because of very intensive work plan for 2018, study tour needs to be postponed to 2019;
- To invite representatives of international financial institutions (development banks, funds) to the meetings of Nexus working groups (upon request from members);
- Institutional gap analysis, including the stakeholder analysis, and capacity needs assessment should be focused on regional processes (e.g. IFAS activities, implementation of previous ASBPs, ASBP-4 planning);
- To formalize the membership of RWG through organization of official nomination process;
- To invite representatives of the Water Basin Organizations "Syrdarya" and "Amudarya" to the RWG meetings;
- To revise the Project Communications Strategy to focus it on regional processes (e.g. IFAS activities and ASBP-4 planning).
- The next meeting of the RWG is planned to be held on 7 June 2018 back-to-back to the Central Asian International Environmental Forum (CAIEF) on June 5-7 in Tashkent, Republic of Uzbekistan.

CA Regional Working Group

- 1.3. To bring investment projects to the attention of investors and donors;
- 1.4. To participate in regional project events: seminars, study tours, conferences.

2.1. Rights

- 2.1.1. To be informed about the global Nexus initiative and opportunities it creates for CA region; about ongoing and planned activities, achieved progress in Central Asia; opportunities to fund implementation of investment projects developed within the Nexus Project;
- 2.1.2. To initiate requests for expert support and training seminars.

2.2. *Obligations*

- 2.2.1. To provide all possible support to project implementation, including promotion of intersectoral approach to achieve WEF security;
- 2.2.2. To take an active part in the work of the RWG.

2. RWG meetings

- 2.3.It is planned to hold two meetings of RWG per year;
- 2.4. RWG meetings will be conducted back-to-back with other relevant events of CAREC, EC IFAS or other partners to save time of RWG's members and resources of the Project.
