STAKEHOLDERS MAP & INSTITUTIONAL ANALYSIS REPORT: FOR BUILDING AND STRENGTHENING INSTITUTIONAL CAPACITY AND COORDINATION MECHANISMS TO GOVERN, FINANCE AND COORDINATE CLIMATE ACTION IN TURKMENISTAN

To facilitate successful climate finance, a coordination mechanism has been developed within the framework of **the first national "Green Climate Fund Readiness Support" Project,** which is being implemented by the Ministry of Agriculture and Environmental Protection of Turkmenistan (MAEP) with the support of the Regional Environmental Center for Central Asia (CAREC). Stakeholders map and institutional analysis have been developed to create a coordination mechanism to coordinate climate action.

Coordination Mechanism (CM)

Coordination mechanism for approval projects of Turkmenistan for their subsequent submission to the Green Climate Fund (GCF) will be of a significant importance to support and promote climate finance for innovation and investments in climate change, adaptation and mitigation processes.

National Designated Authority (NDA)

To effectively interact with the GCF on climate finance, the Ministry of Agriculture and Environmental Protection serves as the National Designated Authority (NDA) for the GCF.

The Inter-Ministerial Commission on Environmental Protection, chaired by the Minister of the MAEPT, is the key coordinating body in the decision-making process on climate change-related issues. Its decisions and recommendations are submitted to the authorized Deputy Chairman of the Cabinet of Ministers for further endorsement by the President of Turkmenistan.

Structure of the Commission


The Inter-Ministerial Commission considers issues on the GCF as an Inter-Ministerial Coordination body. Its working group, chaired by the NDA, provides expert support to evaluate the climate change projects (Technical Expert Group). The Coordination Mechanism includes: an intersectoral coordination, coordination at the level of the ministry, stakeholders – public organizations.
